



VIRTUAL MEETING USER GUIDE

In light of the COVID-19 pandemic, the continuing restrictions on public gatherings and to mitigate the risks to health and safety of our community, shareholders and employees, we will be holding this year's meeting at 3:00pm (Calgary time) on April 29, 2021 by way of a Virtual only meeting.

All shareholders regardless of geographic location and equity ownership are able to attend the meeting online using a computer, tablet or smartphone.

Participation at the Meeting

The virtual meeting is compatible on most devices using the latest version of Chrome, Firefox, Safari, Edge or Internet Explorer 11. Registered Holders, Duly Appointed Proxyholders and Guests are welcome to attend the meeting. However, only Registered Holders of Duly Appointed Proxyholders will be able to ask questions and vote at the meeting.

➤ Notice to Beneficial (Non-Registered) holders

Beneficial or Non-Registered holders (shareholders who hold their shares through a financial intermediary) who have not duly appointed themselves as proxyholder will be able to attend the meeting as a Guest, but won't be able to vote or ask questions at the meeting.

If you are a beneficial shareholder and you wish to participate at the meeting, you will need to appoint yourself as proxyholder by following the instructions set out on the voting instruction form and in the management information circular. Additionally, you will also need to send an email to baytex@odysseytrust.com by 3:00pm (Calgary time) on April 27, 2021 or at least 48 hours prior to the time of any adjournment of the meeting to obtain your username.

➤ Duly Appointed Proxyholders

For instructions regarding the appointment of proxyholders, please refer to "Appointment of a Third Party as Proxy" in the management information circular. Provided the appointment is registered correctly and in time, Odyssey will provide the username to appointed proxyholders via email.

➤ Registered Holders

The 12-digit control number located on the reverse of your form of proxy acts as your username. If you have appointed a 3rd party as your proxy appointee to attend the meeting, you will need to email Odyssey Trust Company at baytex@odysseytrust.com to register the appointment by 3:00 pm (Calgary time) on April 27, 2021 in order for them to receive a username.
