**BAYTEX ENERGY TRUST ANNOUNCES INCREASE  
TO EXCHANGEABLE SHARE RATIO**

Baytex Energy Trust (TSX-BTE.UN) of Calgary, Alberta is pleased to announce the increase to the Exchange Ratio of the Exchangeable Shares of Baytex Energy Ltd. from 1.16040 to 1.17454. This increase will be effective on September 15, 2004.
